Once the weeks insurance has been used it is up to you the purchaser to make sure you have pet insurance to cover any unforeseen circumstances for your puppy / dog as I can not foresee the future. It is your responsibly as the pet owner to have these things in place as I, the breeder, can not be held responsible for any health issues or accidents that may arise in the lifetime of your pup / dog.
SECTION 6: ENDORSEMENTS
Under Kennel Club regulations, there are two endorsements that may be placed on a dog's record, by the registered owner of a dog, whilst the dog in question is still in their possession. A breeder, therefore, is entitled to place two endorsements on a puppy's record with the Kennel Club, as explained below.
The endorsements can be lifted once the pup is 12 months old and I have seen a health vet certificate stating that the named dog above is fit and healthy enough to have a litter or to perform stud duties. If for any reason I was not able to personally lift the endorsement, I give the kennel club full permission to do so as long as a vet health certificate is presented to them stating that the dog is healthy and in a good condition.
If you have paid for pet only and not breeding rights then you will have to pay the extra for the breeding rights as I will then lift the endorsements once paid and vet certificate is shown.
